Dear Residents, Families, and Caregivers,

As a continued effort to keep you informed of any COVID-19 activity, please see updated information on our current numbers.

Since our last letter dated August 14, 2020, there have been **0** resident confirmed and **0** new staff positive reports. In addition, we have had **0** new clusters of respiratory conditions this week for residents and **0** new clusters of respiratory symptoms for staff this week.

The areas in which we were able to move towards in step 2 of the reopening plan have been going well, which would include additional activities and communal dining. The Williamsport Home is entering into step 3 of the reopening plan. Under step 3 we are still required to conduct outdoor visitation when able, indoor visitations are allowed for inclement weather only. The changes that occur in this step are related to increased number of residents participating in communal activities.

The Williamsport Home continues to monitor all requirements from The Department of Health, CDC and CMS to implement best practices in relationship to minimizing exposure risk. It is greatly important for our residents and staff to follow these practices as outlined by our regulatory bodies. We ask that the families ensure that they are also following the proper protocols that we have in place for our visitation as this allows us to ensure we are properly monitoring and minimizing any potential risks. If at any time The Williamsport Home gets a positive COVID-19 case, whether staff or resident, all visitations will cease and we will be required to start over with our reopening plan as per The Pennsylvania requirements for reopening.

A reminder to our visiting families please limit the amount of visitations to two (2) visits per week per resident. Each visit is scheduled for 15 minutes with a maximum of two people per resident. All visitors must maintain at least 6 feet distance from the resident and pass the screening questions.
